New Form - Petition for the Degrees and Background Check Procedures

As per the September 30, 2022 order of the Grand Master, and as prescribed by the Grand Secretary under Grand Lodge By-law Section 13.080, the following changes regarding all **Petitions for the Degrees** will be used:

- 1. Effective immediately, all blank petitions not labeled on the footer of the **Petition for the Degrees** form "Revision 09/29/2022" are to be destroyed and not used for membership application.
- 2. Effective immediately, lodges are required to ONLY accept **Petitions for the Degrees** that say "Revision 09/29/2022" on the footer of the form.
- 3. Effectively immediately, ALL **Petitions for the Degrees** MUST be accompanied with a **Missouri State Highway Patrol Criminal Background Report** (in support of GL By-law Section 13.070) and include the required initiation fee (GL By-law 10.020) before the petition can be officially received.
- 4. Other criminal information reports (i.e. Missouri state courts automated case management system Case.Net, reports obtained from local law enforcement officials, etc.) are not accepted.
- 5. Any **Petition for the Degrees** previously received by the lodge prior to June 1, 2022, and not yet acted upon, must be canceled, and resubmitted by the candidate on the new form, using the new rules.
- 6. Any **Petition for the Degrees** accepted by the lodge but not officially received (ritualistically, by the Master) at a stated meeting before October 1, 2022, can not be received. It must be returned to the petitioner along with any fee presented, and the petitioner must complete a new application candidate on the new form, using the new rules.

The new Petition for the Degrees form has several significant requirements restored (GL By-laws Sections 13.010 & 13.080) that require your attention, and if not completed correctly, can make it unacceptable to receive:

- The form must be completed in the candidate's own handwriting, not typewritten
- The form must be completely filled-in only exception are items that do not apply

To limit the liability that could be incurred by unauthorized release of the sensitive information it contains, the candidate's **Missouri State Highway Patrol Criminal Background Report** must NOT be duplicated. The original copy can be shared with the members of the investigating committee, but upon their submission of their report, it must be physically attached to the candidate's original petition and filed in the lodge secretary's records.

If the candidate has any problem ordering his background report or has any problem with the information on the report, he must be directed to contact the MACHS service for assistance at 573-526-6153 or machs@mshp.dps.mo.gov.

These new rules apply to all officers of the lodge: elected, appointed, or acting. Failure to follow these rules for receiving a **Petition for the Degrees** can result in Masonic Discipline for any or all officers involved, or the lodge as a whole, up to and including suspension of the lodge's charter.

Obtaining a Missouri State Highway Patrol Criminal Background Report

Via USPS Mail:

Requests made by mail require the completion of the "Request for Criminal Record Check Form, SHP-158. This form may be via the Internet at: Criminal Record Check Form (SHP-158) https://www.mshp.dps.missouri.gov/MSHPWeb/PatrolDivisions/CRID/documents/SHP-1582019.pdf or from the lodge secretary. The report fee of \$15.00 must be paid by check or money order (no cash), included with the request form and mailed to the address on the form.

Please note that all mail-in requests submitted on non-MSHP forms will be rejected and returned to the original sender not completed.

Via Computer/Internet

Online requests are initiated through https://www.machs.mo.gov/MACHSFP/home.html

Click the button "Click here to Register with the Name Search Portal"

Click the button "New to this site? Click here to get started"

Click the button "Yes - Continue"

Complete the Public Search – Requestor Information screen. NOTE be SURE to remember your password! You will need to obtain your results. This site is run by the Missouri State Highway Patrol and no one attached with Freemasonry can assist.you to retrieve your password. Click SUBMIT when complete.

You have now created your account and may begin conducting your record check. You will be required to enter your first name and last name, as well as either a date of birth and/or a social security number for report. Once you have entered the required information you may click the "View Shopping Cart" button.

Click the 'Submit' to enter payment for your report.

Credit/Debit cards are the only method of payment available through MACHS. The State Payment Portal accepts all major credit cards including MasterCard, Visa, Discover, and American Express. The report charge is \$15.00 plus the payment processing fee of \$1.25.

Report requests are processed by MACHS personnel. On average MACHS personnel complete requests within two business days but may take up to 7-10 business days, so check back often

To check if your report is complete, log back into the system and go to the "Purchase History" page. If the request is complete, the Submitted/Completed column will read "1/2". Click the "View" button to see and print your report. Enclose that printed report with your completed petition and submit it to the lodge secretary.

Criminal Justice Information Services Division General Information

The Missouri Criminal Records Repository (MCRR) collects, maintains, and disseminates Criminal History Record Information (CHRI) as defined by Sections 43.500 and 589.400, RSMo. CHRI is information collected by criminal justice agencies on individuals and consists of arrests, prosecutions, final dispositions, correctional supervision, and releases. All felony and serious misdemeanor arrests (referred to as reportable arrests), including offender registration information as defined under Section 589.400, RSMo, and all alcohol and drug related traffic offenses are reportable to the MCRR.

Criminal background checks may be requested by means of:

- 1) A **Personal Identifier Search** (name-based) which searches information based on the name, date of birth, and social security number of an individual.
- 2) A Fingerprint Based Search which searches the state's criminal history files by conducting a fingerprint comparison of the applicants fingerprints with the criminal (arrest) fingerprints on file with the Central Repository. Fingerprint images are collected and submitted using the standard federal applicant fingerprint card (FD-258).

The Personal Identifier Search requires a payment of \$15.00 per request. The background check results are considered a "possible match" and will include only open records. Any individual, business, or agency may request and receive open record information by means of a personal identifier search. Open records include:

- Records containing convictions, such as plead guilty to, or convicted of.
- Arrest information that is less than 30 days old from the date of arrest.
- Charges filed from the prosecutor, awaiting final disposition from the court.
- Records that contain a suspended imposition of sentence (SIS) during the probation period.

A Fingerprint Based Search requires a payment of \$20.00 per request. The results of a fingerprint-based background check are considered a "positive match" and will provide either open records or closed (complete) records as requested by the applicant.

An applicant may choose to conduct a fingerprint based criminal record check containing open records thus limiting the dissemination of criminal history information to **only** open record information. The Criminal Justice Information Services (CJIS) Division will release fingerprint-based criminal history information containing only open record information to any individual, business, or agency when requested by the applicant.

An applicant may choose to conduct a fingerprint-based criminal record check for release of closed records thus allowing dissemination of all criminal history information on file with the Central Repository. Closed records will only be released with a record check submitted by means of a fingerprint comparison and will only be released directly to the applicant or to a qualified entity if authorized in accordance with Section 610.120 and Chapter 43, RSMo. Closed records include:

- All criminal history data, including all arrests (filed or not filed charges).
- Charges that have been nolle prossed, dismissed, or found not guilty in a court of law.
- Suspended Imposition of Sentence (SIS) after the probation period is complete.

Notary Letters are provided upon request and require an additional \$2.00 processing fee, per request. A notary letter may be requested with either a personal identifier search or a fingerprint search.

PENALTY — A person who knowingly violates any provision of Sections 43.532, 43.540, 610.100, 610.105, 610.106 or 610.120 RSMo is guilty of a class A misdemeanor.

FBI Record Requests

The FBI only has open files meaning that if someone has the authority to receive the records; they receive all that is on file.

Individuals that need a Federal or Federal Bureau of Investigation (FBI) background check, for personal reasons or for employment purposes for entities not authorized through Missouri State Statute or the Missouri VECHS program, can submit fingerprints with an \$18.00 fee directly to the FBI. For information on how to obtain a federal background check directly from the FBI, please refer to information regarding the FBI's Identity History Summary Check on the FBI's website at www.fbi.gov.
